### **Role and Responsibilities**

- Creating awareness among the students about ragging.
- Pasting anti ragging posters at important places.
- Sending circulars in line with the guidelines given by Government of Madhya Pradesh, Supreme Court of India, UGC/AICTE/PCI.
- Taking precautionary actions to avoid ragging activities inside as well as outside the campus.
- Conducting awareness programs on Anti - Ragging in the form of meetings and sharing PPTs among the students and faculty.
- Collecting undertaking / affidavit from students and parents as per AICTE/UGC/PCI guidelines.
- Conducting meeting whenever required and discuss relevant issues, in consultation with the principal seeking his approval.
- Other duties and responsibilities as when arise.

### **Procedure for lodging complaint and action to be taken**

- The students may feel free to put up a grievance in writing to the member or in-charge of anti-ragging committee.
- The anti-ragging committee will act upon those cases which have been forwarded along with the necessary documents.
- Whosoever directly or indirectly commits, participates in, abets, or propagates ragging within or outside of Institution shall on conviction, be punished as per the rules.

The committee will assure that the grievance has been properly solved in a stipulated time limit provided by the committee.
